1 TERMS OF REFERENCE (Confidential Information Disclosure Notice)

- 1.1 This document may contain confidential information that is the property of African Exploration Mining and Finance Corporation (AEMFC) SOC Ltd.
- 1.2 No part of the contents may be used, copied, disclosed or conveyed in whole or in part to any party in any manner whatsoever other than for preparing a proposal in response to this bid, without prior written permission from African Exploration Mining and Finance Corporation SOC Ltd.
- 1.3 All copyright and intellectual property herein vests with African Exploration Mining and Finance Corporation SOC Ltd.

2 INTRODUCTION

- 2.1 African Exploration Mining and Finance Corporation (AEMFC) is a state-owned mining company. Its core business is the mining of the strategic assets such as coal, for government. AEMFC seeks to appoint two (2) suitably qualified service providers to provide coal transportation services to Eskom Power Stations with a minimum of forty (40) trucks each from contract award to end April 2024.
- 2.2 Thus, the Service Provider is requested to provide a proposal based on the scope of work (Section 5 - SOW).

3 PRE-QUALIFICATION

Only bidders who meet the below Pre-qualification criteria qualify to apply for this tender:

- 3.1 Bidders are expected to subcontract at least 30% of value of contract to a local Exempt Micro Enterprise (EME) and/or Qualifying Small Enterprise (QSE) which is at least 100% owned by black people.
- 3.2 A valid original / certified copy of B-BBEE of Exempt Micro Enterprise (EME) and /or Qualifying Small Enterprise (QSE) of sub-contracted company to be submitted.
- 3.3 Proof of signed Sub-contracting agreement/Memorandum of Understanding/Agreement/ Letter of Intent. Signed commitment to be attached. For sub- contracting bidders are required to submit a B-BBEE certificate from Verification Agency as per their Charter.

Note * The Transport Sector Charter has not been amended or aligned to the 2013 B-BBEE Codes of Good Practice they are still using the 2009 Sector Charter. Therefore they are unable to use the CIPC certificate/affidavit they are still required to use the letter from an accountant of B-BBEE certificate from Verification Agency as per their Charter.

Note: Failure to attach such signed agreement/ MOU/MOA/LOI will lead to bid being non-responsive.

- 3.4 The Transport Sector Charter has not been amended or aligned to the 2013 B-BBEE Codes of Good Practice they are still using the 2009 Sector Charter. Therefore they are unable to use the CIPC certificate/affidavit they are still required to use the letter from an accountant of B-BBEE certificate from Verification Agency as per their Charter.

3.5 Note: "Proof of B-BBEE status level of contributor" means-

- a) The B-BBEE status level certificate issued by an authorized body or person; or
- b) A sworn affidavit as prescribed by the B-BBEE Codes of Good Practice; or
- c) any other requirement prescribed in terms of the Broad-Based Black Economic Empowerment Act; If "proof of B-BBEE status level of contributor" is required for prequalification purposes in terms of PPPFA regulations and is either not submitted by tender submission deadline or deemed invalid; the respective tenderer must be disqualified.

3.6 Minimum B-BBEE level

- a) AEMFC has set a minimum B-BBEE threshold for participation in this RFP process. The minimum B-BBEE threshold in this instance is a B-BBEE with a minimum of 51% owned black people. A bid that fails to meet these pre-qualifying criteria will be regarded as an unacceptable bid.

- b) *BBB-EE practise guide 01 Of 2018 paragraph 14 state:*

“The exception to this is only in the Transport Sector where EMEs have a choice of obtaining accounting officer letter or get verified and be issued with a B-BBEE certificate by SANAS accredited professional or agency because the Transport Sector Code has not been aligned to the amended generic Codes. Also, start-ups that are EMEs but wish to tender for contracts of R10 million in value or above must be verified using the QSE scorecard, and for tenders of R50 million and above must be verified using the generic scorecard.”

Note: A bidder that fails to meet any pre-qualifying criteria stipulated in the bid documents is an unacceptable tender (section 4 (2) of PPPFA Regulations.

4 OBJECTIVE CRITERIA

- 4.1 Objective criteria in terms of sections 2(1) (d), (e) and(f) of the PPPFA will be used in awarding the tender not to the highest scorer; and the objective criteria for this tender are as follows:

5 SCOPE OF WORK (SOW) (REQUIREMENTS)

- 5.1 African Exploration Mining and Finance Corporation SOC Ltd (AEMFC) has a contract with Eskom to supply between 102 200 and 145 600 tons of crushed coal per month to Eskom Power Stations. The bidders will be expected to transport between 102 200 tons and 145 600 tons.

- 5.2 The base delivery stations points will be Kendal and Kusile Power stations, however the delivery points might change from time to time depending on the Eskom requirements.
- 5.3 The mine is looking for coal transporters to transport quantities specified above and using a maximum of 22-meter interlinked side tipper trucks.
- 5.4 Prior to contracting AEMFC will require the following:
- 5.4.1 Minimum available trucks must be Forty (40) per bidder;
 - 5.4.2 Proof of tracking devices installed in trucks (installation certificates) of which tracking records will be requested by the mine at any given time;
 - 5.4.3 Proof of insurance should be provided;
 - 5.4.4 Valid Rotran disc-coloured copies (A4) required for proof of truck certification with Eskom (truck registration, reference ID and induction expiry to be clearly visible). Induction will be verified with Eskom.

NB: Mine working on a 24/7 Hour operation (from 06:00 to 18:00 and 18:00 to 06:00)

Note: There is a possibility that distances and destinations might change from time to time depending on operational requirements, such as construction, etc.

6 SERVICES, FACILITIES, AND INFORMATION TO BE SUPPLIED BY THE BIDDER

- 6.1 Ensure compliance with all Eskom requirements (current and future) at own cost including Rotran compliance;
- 6.2 Comply with all labour legislation;
- 6.3 Provide own tarpaulin personnel;
- 6.4 Ensure compliance to mine rules;
- 6.5 Provide own PPE; and
- 6.6 Have necessary support services (in case of emergency).
- 6.7 Transporters to provide maintenance records as and when required
- 6.8 24/7 Compulsory Supervision with own vehicle
- 6.9 Trucks yard and maintenance workshop
- 6.10 Any other required resources at all times when operating on the mine
- 6.11 Required to purchase access card from AEMFC at a cost of R130.00 per truck driver
- 6.12 Ensure all truck drivers have a Tontrac Access card, Access card available at AEMFC for R130.00

- 8.1 There shall be no public opening of the Bid received, however the list of Bids received may be published on the AEMFC website or National Treasury e-tender portal unless specifically provided for in the RFP.
- 8.2 Bids submitted by means of email, telegram, telefax, facsimile or similar means shall not be considered.
- 8.3 Bidders will be disqualified in the event of there being scratching out, witing over or painting out

rates or information, affecting the evaluation of the bid, without initialling next to the amended rates or information.

8.4 Bidders will be disqualified in the event of the use of correction fluid (e.g. tippex), any erasable ink, or any erasable writing instrument (e.g. pencil).

8.5 Bidders will be disqualified if the entity or any of its directors is listed on the register of Bid Defaulters in terms of the Prevention and Combating of Corruption Activities Act of 2004 as a person prohibited from doing business with the public sector.

11.2 JOINT VENTURE /CONSORTIUM AGREEMENT

- If the bidder is a Joint Venture or Consortium, a Joint Venture / Consortium agreement signed by all member entities of the Joint Venture or Consortium must be attached together with the registration document of all member entities.

11.3 BROAD BASE BLACK ECONOMIC EMPOWERMENT (B-BBEE) Act

- Valid Original or Certified Copy of B-BBEE Certificate/ Sworn Affidavit for EMEs and QSEs.
- If the bidder is a Joint Venture or Consortium, a consolidated B-BBEE certificate (of the Joint Venture or Consortium (inclusive of all member entities) must be submitted.
- AEMFC reserves the right to verify the B-BBEE certification against the actual turnover as per Annual Financial Statements submitted by the bidder. Any discrepancy between the certification and the actual turnover as verified by AEMFC arising out of any*

misrepresentation in this regard shall lead to a disqualification.

- d) Further, the original or certified copy of an individual or consolidated B-BBEE certificate will also be used for awarding preference points. The B-BBEE certificate must be submitted on the day of bid closure.
- e) B-BBEE status will be scored out of 20 points in accordance with PPPFA. If a tenderer fails to submit proof of B-BBEE status level, the tenderer will not be disqualified (except if B-BBEE level is a pre-qualification criterion). The tenderer will, however, be awarded 80 points for price and will score 0 points for B-BBEE level /status (out of 20).

11.4 NATIONAL TREASURY'S SUPPLIER DATABASE (CSD) REGISTRATION

- a) Bidders must submit proof of registration on the National Treasury's Central Supplier Database (CSD).
- b) Bidders are requested to register on the National Treasury CSD and include the copy of supplier number in order to enable the institution to verify the supplier's tax status on CSD.

11.5 FINANCIAL STATEMENTS

Bidders to proof of financial Soundness - Annual Financial Statements:

- a) If a bidder is a registered company required by law to have its annual financial statements audited or independently reviewed in compliance with the requirements of the Companies Act, Act No. 71 of 2008 , or any other law, audited or independently reviewed annual financial statements, as the case may be, prepared within six(6) months of the end of the bidders most recent financial year together with the audited or independently reviewed annual financial statements for two immediately preceding financial years, unless the bidder was only established within the past three (3) years in which case all of its annual financial statements must be submitted.
- b) If a bidder is a registered close corporation, annual financial statements in compliance with the provisions of the Close Corporation, annual financial statements in compliance with the provisions of the Close Corporations Act, Act No. 69 of 1984, prepared within nine (9) months of the end of the bidders most recent financial year together with the annual financial statements for the two immediately preceding financial years, unless the bidder was only established within the past three (3) years in which all of its annual financial statements must be submitted.
- c) Annual financial statements submitted must comply with the requirements of the Companies Act or the Close Corporations Act.
- d) If the bidder only commenced business within the past three years, the bidder is required to submit annual financial statements in compliance with the provisions of (5.1) and (5.2) above for each of its financial years since commencing business.
- e) If a bidder is not required by law to have its annual financial statements audited or independently reviewed, or is not a Close Corporation, then non-audited annual financial statements for the periods referred to above must be submitted.
