2 INTRODUCTION

- 2.1 African Exploration Mining and Finance Corporation (AEMFC) is a state-owned mining company. Its core business is the mining of the strategic assets such as coal, for government. AEMFC intends to appoint a service provider for the removal and disposal of waste over a period of 3 years. The type of waste generated at Vlakfontein mine include;

- 2.1.1 General waste
- 2.1.2 Hazardous waste
- 2.1.3 Scrap metal
- 2.1.4 Office paper

- 2.2 Thus, the Service Provider is requested to provide a proposal based on the scope of work (Section 5 - SOW).

3 PRE-QUALIFICATION

Only bidders who meet the below Pre-qualification criteria qualify to apply for this bid:

- 3.1 Bidders who are Exempt Micro Enterprise (EME) and/or Qualifying Small Enterprise (QSE) level 1-4. A valid original / certified copy of BBBEE or affidavit. 51% owned by black people

- 3.2 **Note: "Proof of B-BBEE status level of contributor" means-**

- a) the B-BBEE status level certificate issued by an authorized body or person; or
- b) A sworn affidavit as prescribed by the B-BBEE Codes of Good Practice; or
- c) any other requirement prescribed in terms of the Broad-Based Black Economic Empowerment Act; If "proof of B-BBEE status level of contributor" is required for prequalification purposes in terms of PPPFA regulations and is either not submitted by tender submission deadline or deemed invalid; the respective tenderer must be disqualified.

- 5.3 Rental of one scrap metal 6m³ waste skip without a lid. The scrap metal will be removed as and when the skip is full. The mine must be reimbursed per ton based on its weighbridge net mass.
- 5.4 Rental of one container for storage and removal of used office paper. The waste papers must be removed **once a month.**
- 5.5 The general and hazardous waste must be removed and disposed of **twice a month**

- 5.6 All waste removed on site must be accompanied by a waste removal receipt/manifest/safe disposal certificate.
- 5.7 The contractor **must** have a valid certificate of Institute of Waste Management of Southern Africa (IWMSA) membership certificate.
- 5.8 The contractor **must** have a valid hazardous waste transportation permit as per the relevant legislations.

- 8.3 Bidders will be disqualified in the event of there being scratching out, witing over or painting out rates or information, affecting the evaluation of the bid, without initialling next to the amended rates or information.
- 8.4 Bidders will be disqualified in the event of the use of correction fluid (e.g. tippex), any erasable ink, or any erasable writing instrument (e.g. pencil).
- 8.5 Bidders will be disqualified if the entity or any of its directors is listed on the register of Bid Defaulters in terms of the Prevention and Combating of Corruption Activities Act of 2004 as a person prohibited from doing business with the public sector.

10.3 BROAD BASE BLACK ECONOMIC EMPOWERMENT (B-BBEE) Act

Any discrepancy between the certification and the actual turnover as verified by AEMFC arising out of any misrepresentation in this regard shall lead to a disqualification.*
- Further, the original or certified copy of an individual or consolidated B-BBEE certificate or sworn affidavit will also be used for awarding preference points. The B-BBEE certificate must be submitted on the day of bid closure.
- B-BBEE status will be scored out of 20 points in accordance with PPPFA. If a tenderer fails to submit proof of B-BBEE status level, the tenderer will not be disqualified (except if B-BBEE level is a pre-qualification criterion). The tenderer will, however, be awarded 80 points for price and will score 0 points for B-BBEE level /status (out of 20).

10.4 NATIONAL TREASURY'S SUPPLIER DATABASE (CSD) REGISTRATION

- a) Bidders must submit proof of registration on the National Treasury's Central Supplier Database (CSD).
- b) Bidders are requested to register on the National Treasury CSD and include the copy of supplier number in order to enable the institution to verify the supplier's tax status on CSD.

10.5 FINANCIAL STATEMENTS

Bidders to proof of financial Soundness - Annual Financial Statements:

- b) If a bidder is a registered close corporation, annual financial statements in compliance with the provisions of the Close Corporation, annual financial statements in compliance with the provisions of the Close Corporations Act, Act No. 69 of 1984, prepared within nine (9) months of the end of the bidders most recent financial year together with the annual financial statements for the two immediately preceding financial years, unless the bidder was only established within the past three (3) years in which all of its annual financial statements must be submitted.
- c) Annual financial statements submitted must comply with the requirements of the Companies Act or the Close Corporations Act.
- d) If the bidder only commenced business within the past three years, the bidder is required to submit annual financial statements in compliance with the provisions of (5.1) and (5.2) above for each of its financial years since commencing business.

 - b) Functionality (Technical)
 - c) Price and B-BBEE status level of contribution in accordance with PPPFA and its Regulations.

12.3 PHASE 1 Compliance Check of Required documents

All proposals submitted will be evaluated to determine that bidders comply with the pre-qualification criteria.

12.4 PHASE 1 Compliance Check of Required documents

All proposals submitted will be evaluated to establish compliance to the commercial requirements such as for completion and signing of Standard Bidding Documents (SBD) forms, and submission of Central Supplier Database (CSD) registration number.
