2 INTRODUCTION

African Exploration Mining and Finance Corporation (AEMFC) is a subsidiary of Central Energy Fund (CEF). Its core business is the mining of the strategic assets such as coal. Mining is done on behalf of government. AEMFC seeks to appoint a panel of maximum four suitably qualified service providers for repair and maintenance of mobile mining machinery on an as and when required basis for a period of 12 months.

3 SCOPE OF WORK (SOW) (REQUIREMENTS)

AEMFC is looking to appoint a panel of suitably qualified service providers for repair and maintenance of mining machinery at Vlakfontein Mine for a period of 12 months from signing of contract. The tender specifications shall include but not limited to the following;

3.1 Labour hire

- 3.1.1** Provision of suitably qualified maintenance personnel for conducting repairs and maintenance on machinery as well as to assist the Mine shift Mechanics:
 - ☐ 2 x Qualified Diesel Mechanic
 - ☐ 2 x Semi Skilled Diesel Mechanic Assistant
 - ☐ 2 x General labourer
- 3.1.2** All Maintenance personnel to be posted at Vlakfontein Mine will report daily to the Mine General Engineering Supervisor (GES) and attendance time sheets will be signed by the Foreman.
- 3.1.3** Maintenance personnel to be posted at Vlakfontein Mine will only work a day shift system from Monday to Friday. Each shift will commence at 06H00am ending at 15H00pm.

3.2 Overhauls, repairs and component replacement

Consist of overhauls, rebuild and repair of various components of the equipment and the sub-assemblies.

NB: Components listed on the BOQ Annexures are a guideline for costing purposes, meaning component replacements is not limited to those on the BOQ's.

3.3 Hydraulic system

Consist of pumps, cylinders, hoses and fittings for repairs of the various equipment.

3.4 Differential and gearbox

Includes transmission, gears, shaft, clutches and synchronises hub which will be repaired or replaced if necessary.

3.5 General repairs

Consist of repairing of axles/drive shafts, bucket repairs, line boring, undercarriage repairs, upholstery work and minor body repairs, exhaust repairs, brake system, suspensions.

3.6 Machine Service Kits

This involves supply of service kits for the various Open cast machines as per the Mine maintenance strategy. The services to be carried out are ranging from 250 – 2000hrs service per machine.

4 GENERAL REQUIREMENTS

- 4.1** The bidder must provide qualified artisan (Red seal Diesel Mechanics) to maintain and repair the equipment.
- 4.2** The Artisan should be aligned with the shift system used at the mine. The mine operates a two-shift system, which starts from 6h00 until 18h00 and also from 18h00 until 06h00.
- 4.3** All the support team vehicles to be used at the mine must comply with the mine's standards and procedures.
- 4.4** All personnel required to provide support to the maintenance service will be required to undergo induction and medical test at a cost to the bidder of approximately R275 and R500 (Vat Excl) per person respectively.
- 4.5** All work undertaken from time to time will be randomly inspected by an official of the Mine.
- 4.6** Visitation by an official of the mine will be compulsory to inspect the bidders workshop. Such inspection of workshop shall include but not limited to the following:
 - Workshop to be well lit and secured.
 - Be adequately ventilated and where necessary have local exhaust ventilation
 - Have a good standard of housekeeping.
 - Be provided with adequate fire-fighting equipment.
 - Only contain flammable material necessary for the day to day operation of the workshop.
 - Have clearly identified pedestrian routes and, where possible, reversing of mobile equipment should be avoided.
 - Have pits that are covered when not in use or have guard rails in place.
 - Have inspection scheme for all tools and equipment so that they are safe to use.

- Have access to workstations restricted to maintenance personnel.
 - Have a gas bottle racked and gas welding bottles should be fitted with a flashback arrestors.
 - Control the use of naked flames.
 - Have adequate sanitary and hygienic washing facilities.
 - Have procedure for waste management of used oils, tyres, batteries, etc.
- 4.7 All equipment, component parts, fittings and materials supplied and/or installed, shall conform in respect of quality, manufacturer, test and performance to the requirements of the applicable current SANS specifications and codes, except where otherwise specified or approved by the Engineer in writing.

- 8.1.1 Bidders are expected to subcontract at least 30% of value of contract to a local Exempt Micro Enterprise (EME) and/or Qualifying Small Enterprise (QSE) that is at least 51% owned by black people. A valid original / certified copy of BBBEE or affidavit of Exempt Micro Enterprise (EME) and /or Qualifying Small Enterprise (QSE) of sub-contracted company to be submitted.
- 8.1.2 Proof of signed Sub-contracting agreement/ memorandum of agreement/understanding/letter of intent between the main bidder and subcontracting partner. Signed commitment to be attached. Failure to attach such signed agreement will lead to disqualification.

Note: A bidder that fails to meet any pre-qualifying criteria stipulated in the bid documents is an unacceptable tender (section 4 (2) of PPPFA Regulations.

If a tenderer fails to submit proof of B-BBEE status level, the tenderer will not be disqualified (except if B-BBEE level is a pre-qualification criterion). The tenderer will, however, be awarded 80 points for price and will score 0 points for B-BBEE level /status (out of 20).
