2 INTRODUCTION

- 2.1 African Exploration Mining and Finance Corporation (SOC) Ltd ("AEMFC") is a state-owned Mining Company established to secure South Africa's energy supply primarily through the mining and supply of coal for the generation of electricity, as well as securing other resources that will provide energy for the future, including key minerals for beneficiation in the energy and steel value chain. As a growing company, AEMFC is currently operating an opencast coal mine (Vlakfontein Mine) established in 2011 which is located near Ogies in Mpumalanga Province.
- 2.2 Thus, the Service Provider is requested to provide a proposal based on the scope of work (**Section 6 - SOW**).

6 BACKGROUND

- 6.1 Vlakfontein Mine is generating dust which must be managed and controlled as required in the approved Environmental Management Programme (EMP). The activities that have a potential to generate dust at the mine are vehicles and trucks travelling on the mine road, the crushing and screening plant, mine rehabilitation, blasting activities, etc. The mine currently has **13 dusts fall out monitoring buckets stands**, located at different points around the mine, of which 8 will be single dust fall out buckets and 4 to be converted to wind directional (one stands with 4 buckets) dust monitoring buckets with the advice from the service provider on the strategic monitoring points

7 SCOPE OF WORK (SOW) (REQUIREMENTS)

- 7.1 To monitor dust samples and analyze for 9 single dust fall out monitoring buckets on a monthly basis;
- 7.2 To monitor dust samples and analyze for four wind directional (with 4 buckets each) on a monthly basis;
- 7.3 Sign and submit the field form to the mine personnel as a proof that the service provider visited the mine to collect the samples;
- 7.4 To provide dust monitoring reports and lab results on or before the **03rd of each month**;
- 7.5 The report must be in the form of graphs showing the trends of the dust generated per month;
- 7.6 The dust monitoring reports must be provided in a word and excel format;

- 14.1 After the closing date of the bid invitation, an appointed evaluation committee of AEMFC officials and / or external parties/ consultants (where necessary) will evaluate the proposal of the service providers.
- 14.2 The committee will evaluate each of the bid proposals received against the approved criteria as stated below:
 - a) Compliance Check of required documents
 - b) Functionality (Technical)
 - c) Price and B-BBEE status level of contribution in accordance with PPPFA and its Regulations.
- 14.3 **PHASE1: Compliance Check of Required documents**
