The electricity connection and switch on has been done, however the community members are still complaining about electricity not working. The electricity was switched on last year June 2021. Therefore, the service providers involved in providing electrical building services are requested to provide quotation for the inspection and assessment of each house based on the following points:

- Inspection and assessment of the electrical connection for each (24) houses.
- Provide a report about the findings and recommend the plans that must be implemented.
- Provide electrical building COC for each house
- Confirm availability of power supply to each house
- Confirm status of the electricity prepaid meter box for each.
- Each house member is required to sign confirmation that you have inspected and assessed their houses

9 DISCLAIMERS

11 TAX COMPLIANCE

Respondents must be compliant when submitting a proposal to AEMFC and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).
